Understanding The Survivor Benefit Plan

The Survivor Benefit Plan (SBP) enables military retirees to financially protect a spouse or other survivors by ensuring that a portion of retired pay continues after the retiree's death, providing a guaranteed income to the survivors.

The decision to enroll in this program is made prior to retirement and is irrevocable. The retiring servicemember's spouse must consent to any protection level that is less than 100 percent. If no reduction is elected, the cost for spouse-only coverage is 6.5 percent of gross military retired pay.

Everyone's situation is different. As you consider the SBP and alternatives, there are some things to keep in mind. *Continued on page 4*

Caring Hearts



Caring Hearts is a local food drive, directed by the First United

Methodist Church in O'Fallon and supported by AFSA Chapter 872 on a monthly basis.

Our Chapter POC is TSgt Larry Adams and MSgt Amber Callahan. They schedule volunteers to assist in assembling and filling food boxes, which many churches in the surrounding community utilize in order to purchase essential sustenance for their underprivileged members and elderly homebound. In addition to assisting those in need, local citizens can order boxes if they wish to purchase food in bulk.

The Caring Hearts food drive occurs every fourth Saturday at the church. Volunteers meet by 0800 to assemble approximately 110-130 food boxes, but holiday seasons in November and December boast upwards of 250 food boxes! This quarter, AFSA provided 113 volunteers. Collectively they volunteered over 134 hours and filled 336 food boxes. What a blessing to the community! Finally, Chapter 872 donated \$500 to offset the cost of increased safety requirements. Thank you, Chapter 872, for your invaluable support!

Jefferson Barracks

Periodically, AFSA Chapter 872 invites local veterans out for a day of fun with our chapter members. The mission for the program is to utilize therapeutic benefits of bowling or golf, such as increased strength, balance, range of motion, grip strength, endurance, competition, fun, and social skills with veterans who are disabled or wounded.



In August, MSgt Ronald Zokal coordinated a "Boots on the Lane" event, hosting over 40 veterans from Jefferson Barracks in St. Louis. the chapter provided 48 volunteers and 184 volunteer hours to ensure the veterans were well taken care of. Thanks again men and women of Chapter 872 for yet another successful event!

The Mission Continues





The Mission Continues program empowers veterans to project their military mindset and skills through volunteer opportunities in the community. In July, Chapter 872 sent volunteers to the 4th Annual Summer Slam Service project at Powder Valley Conservation Nature Center in Kirkwood, Missouri. The Summer Service Slam is a yearly project of The Mission Continues and FOX Sports Midwest, bringing together both veterans and volunteers from the public for a focused day of service work.

More than 400 volunteers of Veterans and civilians worked along side one another on a variety of projects to improve the nature center. Some of the accomplishments that took place amongst the 112 acres of oak-hickory forest grounds were replacing 4 fences, building a fire ring and seating area for public programs, cleaning a 3,000 gallon aquarium, servicing five miles of hiking trails by adding mulch and creating log barriers, building benches, repainting a gazebo, and removing countless amount of invasive honeysuckle. Addressing VA issues! "Long wait times for veterans seeking medical care erupted into a scandal this year, which led to the resignation of VA Secretary Eric Shinseki, calls from both parties to fire officials who covered it up, the termination of bonuses for senior officials, and reforming the entire department." In light of inordinate wait times for care and documented VA misrepresentation on these wait times, House and Senate VA committee leaders are hoping for a corrective bill. Legislation pushed by Senate Veterans Affairs Committee Chairman Bernie Sanders, I-Vt., and Sen. John McCain, R-Ariz., would cost an estimated \$50 Billion per year (according to the Congressional

Budget Office) Sanders says he wants to use "emergency spending" to pay for the legislation. House-proposed legislation would be funded through offsets in other government spending programs. The major expense of either bill would result in letting veterans experiencing long waits or who are not near a VA medical clinic get care in non-VA facilities.

According to a *VA press release*, "New burial regulations effective now will allow the VA to automatically pay the max amount allowable under law to most eligible surviving spouses quickly and efficiently, without a written application. "Under former regulations, VA paid burial benefits on a reimbursement basis, which required survivors to submit receipts for relatively small one-time payments that VA generally paid at the max amount permitted by law.

We would like to say thanks and keep up your support; utilizing CAPWIZ to know the issues and alert your representative. AFSA is continuing to see success on Capitol Hill for our AD, Reserve, Guard, veterans and retired. With elections upcoming I urge you to check out MEGA-vote and learn how your representatives are voting on military issues. So you can make an informed decision when you vote.

Potential Advantages:

- No evidence of insurability is required
- No suicide or incontestability clauses
- Benefits are tied to retired pay increases
- SBP costs are not subject to federal income tax or state income tax in most states
- Survivor's benefits are subject to federal taxes, but in most cases are eligible fo runlimited marital deduction
- Benefits are not subject to garnishment, lien, or other legal processes
- Benefits may be payable for the lifetime of beneficiary

Potential Disadvantages:

- No residual estate remains after death or marriage of designated beneficiary
- Monthly benefit is subject to state income tax in some states
- Preferred risks subsidize uninsurable risks

Additionally, SBP costs, benefits, and provisions are continuously subject to revision by legislative and administrative action. The Survivor Benefit Plan may contribute significantly to your loved ones' financial well-being and should be considered part of an overall retirement income strategy to address your needs and goals. Chapter 872 had the utmost pleasure of hosting AFSA CEO, CMSgt (ret) Rob Frank, and his wife, Mendy the weekend of Scott Air Force Base's 29th Annual Retiree Appreciation Day, as Chief Frank was the keynote speaker for the event. During his three-day visit, Chapter 872 kept him busy visiting the Airmen of some Scott Air Force Base agencies. TSgt David Lang, 618 TACC, gave Chief Frank and Mendy a tour of TACC and provided the 618 TACC mission brief. The 618 TACC plans, schedules, and directs a fleet of nearly 1,200 mobility aircraft in support of combat delivery and strategic airlift, air refueling, and aeromedical evacuation operations around the world.

Chapter 872 Executive Council took Chief Frank and Mendy to dinner at Eckert's where Chief Frank met the Executive Council. At dinner Chief Frank and Mendy heard all of the 'goodness' that Chapter 872 is currently involved in and discussed upcoming events that will be hosted by the Chapter. Chief Frank and Mendy had breakfast with the First Sergeants Council of Scott Air Force Base and had office calls with the USTRANSCOM SEL, Chief Master Sergeant William Turner and the 375 Air Mobility Wing Command Chief, Chief Master Sergeant Wesley Mathias. Chief Frank also had the opportunity to meet the Airmen of the 375 Civil Engineer Squadron Fire Department and the Airmen of the 375 Security Forces Squadron. Chief Frank received a tour of both facilities and briefed the Airmen getting ready for guard mount.

Lastly, Chief Frank briefed the Air Force Space Command Top 4 and did a 'working lunch' with Chapter 872's general membership. Chief Frank reminded

those in the audience that AFSA is a federally chartered non-profit organization presenting the professional and personal interests of the Total Force . . . Active Duty, Guard, Reserve, Retirees, and their families. He also briefed some of the



issues going on legislatively on Capitol Hill and ensured us that there are exciting upcoming changes with AFSA overall. Chief Frank and Mendy ended their visit by being the keynote speaker for Scott Air Force Base's 29th Annual Retiree Appreciation Day to approximately 200 retirees. Chief Frank reminded those in the audience that AFSA works very hard to represent each of them to make sure that 100% of Congress understands what it is like to be a Veteran and Retiree.
